- a2. Recommendation for Annual Election of Committee Chair and Vice Chair.** Ms. Campbell presented this item to the Committee noting that the FCC has not made selections to fill the seats of those Board members whose terms expired on December 31, 2011. Ms. Campbell recommended and the Committee agreed that, consistent with past practice, this item be deferred until those selections are made with the current chair and vice chair continuing to serve in their present positions.
- a3. Approval of 2nd Quarter 2012 and 2012 Annual Schools and Libraries Support Mechanism Programmatic Budgets.** Mr. Belden presented this item to the Committee.

RESOLVED, that the USAC Schools & Libraries Committee, having reviewed at its meeting on January 30, 2012, a summary of the 2nd Quarter 2012 support mechanism demand estimates, including administrative costs, hereby directs USAC management to proceed with the required February 1, 2012 filing to the FCC on behalf of the Committee. Management may make adjustments if the variance is equal to or less than \$10.0 million or may seek approval from the Schools & Libraries Committee Chair to make adjustments if the variance is greater than \$10.0 million but no more than \$15.0 million.

- a5. Action on Seven USAC Internal Audit Division Schools and Libraries Support Mechanism Beneficiary Audit Reports.** Mr. Chris Smith, Manager, Internal Audit, presented this item to the Committee.

On a motion duly made and seconded and after discussion, the Committee adopted the following resolution:

RESOLVED, that the USAC Schools & Libraries Committee, having reviewed the USAC Internal Audit Division Schools and Libraries Support Mechanism Beneficiary Audit Reports listed in Exhibit I to the issue paper together with management's responses thereto, accepts the recommendation of USAC management and hereby deems such reports final.

- i1. Schools and Libraries Support Mechanism Update.** Mr. Blackwell presented this item to the Committee, noting that:
- The Funding Year 2012 application filing window will open at noon Eastern Time on Monday, January 9, 2012 and will close at 11:59 p.m. Eastern Time on Tuesday, March 20, 2012. The filing window will be open for 72 days.
 - USAC management submitted the Funding Year 2012 Schools and Libraries Program Integrity Assurance (PIA) FCC Form 471 Review Procedures to the FCC for review and approval on December 9, 2011. As requested by the FCC, USAC management submitted the procedures 30 days prior to the opening of the Funding Year 2012 application filing window.
 - USAC released Funding Year 2011 Wave 27 Funding Commitment Decision Letters (FCDLs) on December 28, 2011. As of December 31, 2011, funding commitments total approximately \$1.45 billion.

- USAC released Funding Year 2010 Wave 79 FCDLs on December 29, 2011. As of December 31, 2011, funding commitments total approximately \$2.94 billion.
- USAC released Funding Year 2009 Wave 95B FCDLs on November 30, 2011. As of December 31, 2011, funding commitments total approximately \$2.84 billion. USAC also released the last regular Funding Year 2009 wave this quarter.
- On November 25, 2011, the FCC released a Public Notice (DA 11-1943) announcing that the Office of Management and Budget (OMB) has approved the revised instructions accompanying the FCC Form 479 (Certification by Administrative Authority to Billed Entity of Compliance with the Children's Internet Protection Act) and FCC Form 486 (Receipt of Service Confirmation Form).
- USAC Internal Audit Division (IAD) staff completed the final follow-up audit that was classified as a withdrawal or disclaimer from Round 3 of the FCC Office of Inspector General (OIG) USF audit program for Schools and Libraries Program beneficiaries.
- IAD staff is performing a small number of Beneficiary and Contributor Audit Program (BCAP) audits of Schools and Libraries Program beneficiaries.
- USAC staff conducted eight successful one day applicant training sessions for Funding Year 2012. The trainings were held in Washington, DC; Newark, NJ; Minneapolis, MN; Portland, OR; St. Louis, MO; New Orleans, LA; Los Angeles, CA; and Orlando, FL. A record number of over 1,500 program participants attended the trainings.
- The Helping Applicants to Succeed (HATS) program has completed its third year of being managed in-house by USAC. In 2011, the HATS team conducted 1041 HATS-type visits; 211 visits were conducted in person, 105 by telephone and videoconference, and 725 in targeted outreach projects. The HATS team initiated outreach with applicants in 50 states, the District of Columbia, Puerto Rico, Guam and Saipan.
- USAC has developed a Schools and Libraries Program outreach plan for 2012, presenting proposed activities to educate and communicate with program audiences about how to understand and participate successfully in the Schools and Libraries Program.
- The average time to process an invoice line was seven days in November 2011. The invoicing team processed 98.3 percent of incoming invoice lines within 30 days.

- i1. Schools and Libraries Support Mechanism Update.** Mr. Blackwell presented this item to the Committee, noting that:

- The Funding Year 2012 application filing window successfully opened at noon Eastern Time on Monday, January 9, 2012 and closed at 11:59 p.m.

To expedite navigation, please use the bookmarks located in the Navigation Pane.

Eastern Time on Tuesday, March 20, 2012. The application filing window was open for 72 days. At the close of the application filing window, USAC had received a record 46,000 Funding Year 2012 FCC Forms 471 requesting approximately \$4.8 billion in funding requests.

- USAC released Funding Year 2011 Wave 40 Funding Commitment Decision Letters (FCDLs) on March 27, 2012. As of March 31, 2012, funding commitments total approximately \$2.04 billion.
- USAC released Funding Year 2010 Wave 91 FCDLs on March 28, 2012. As of March 31, 2012, funding commitments total approximately \$3.06 billion.
- On March 6, 2012, the FCC released a Public Notice (DA 12-344) which established the comment dates for the Universal Service Lifeline Further Notice of Proposed Rulemaking. The FCC is seeking comment on proposals to reform and modernize the Lifeline Program, which includes administering digital literacy training in conjunction with the Schools and Libraries Program.
- The USAC Internal Audit Division (IAD) performed follow-up work on audits that were classified as withdrawals or disclaimers from Rounds 2 and 3 of the FCC Office of Inspector General (OIG) USF audit program for Schools and Libraries Program beneficiaries. The final Report on Round 3 was submitted to the FCC for review.
- USAC IAD staff is performing Beneficiary and Contributor Audit Program (BCAP) audits of Schools and Libraries Program beneficiaries. Seven audits will be presented to the Committee at the April meeting.
- On March 2, 2012, USAC announced the registration for the spring service provider training sessions. The training sessions will be held on May 10, 2012 in Atlanta, Georgia (281 registered) and on May 15, 2012 in Los Angeles, California (172 registered). USAC received a near record number of early registrations.
- The Helping Applicants to Succeed (HATS) team has conducted 188 HATS-type visits of which 38 visits were conducted in person, 55 by telephone and videoconference and 95 in targeted outreach projects. Thus far in 2012, the HATS team has initiated outreach with applicants in 32 states.
- The average time to process an invoice line was four days in February 2012. The invoicing team processed 99 percent of incoming invoice lines within 30 days.
