#### 11/22/2011 - FY2012 Form 471 Application Filing Window Dates Announced

The FCC Form 471 application filing window for Funding Year 2012 will open at noon on Monday, January 9, 2012 and will close at 11:59 PM EDT on Tuesday, March 20, 2012. The filing window will be open for 72 days. Be sure to review the FY2012 Eligible Services List for details on products and services that are eligible for E-Rate discounts in FY2012, and continue to check the USAC website for additional details. We will issue the customary letter to the field around the time that the FCC Form 471 application filing window opens to provide filing information and deadline reminders related to the window. Meanwhile, keep the following in mind:

You can file an FCC Form 470 now if you are ready to do so; you don't need to wait for the window to open. To file an FCC Form 470 online, go to the Apply Online page and click on the "Create Form 470" button.

You must wait 28 days after the FCC Form 470 is posted to the USAC website before you can close your competitive bidding process, select a service provider, sign a contract (if applicable), and submit an FCC Form 471. If you issue an RFP after the FCC Form 470 is posted, you must wait 28 days from the release of the RFP to select a service provider.

Tuesday, February 21, 2012 is the last day to post an FCC Form 470 to the USAC website or issue an RFP and still complete all of these actions before the window closes

If you file your FCC Form 470 on paper, we need to receive it by Tuesday, February 14, 2012 to give us time to complete data entry before February 21, 2012.

Item 21 attachments to the FCC Form 471 must be submitted by the close of the filing window. If you file your Item 21 attachment online, you must click on the "Submit" button at the bottom of the last page before the window closes. Otherwise your Item21 Attachment will not be sent to us.

# 9/28/2011 - FY2012 Eligible Services List Released

On September 28th, the FCC has released the eligible services list  $\frac{1}{2}$  (ESL) for funding year 2012 for the schools and libraries universal service program (E-rate). The ESL identifies the services and products that are eligible for E-rate funding. In the ESL Public Notice, the FCC proposed minor changes and other edits to the ESL to provide clarifications or additional information only, and did not change the eligibility status of any services in the E-rate program. By this order, the FCC adopts most of the clarifications proposed in the ESL Public Notice, with some minor modifications as described in DA-1160 .

#### 9/19/2011 - First FY2010 Wave with P2 Commitments at 80%

On Wednesday, September 21, USAC will issue FY2010 Wave 67 Funding Commitment Decision Letters. This is the first wave to include commitments for approved Priority 2 (Internal Connections and Basic Maintenance) funding requests at the 80% discount level.

Reviews of FY2010 Priority 2 FRNs at discount levels below 80% will begin soon. Be sure to monitor the preferred mode of contact you indicated on your Form(s) 471 and respond promptly to PIA requests for information.

# 6/27/2011 - FCC Establishes Comment Period for FY2012 Eligible Services List

On June 24, 2011 the Federal Communications Commission (FCC) released a Public Notice (http://transition.fcc.gov/Daily\_Releases/Daily\_Business/2011/db0624/DA-11-1096A1.pdf \( \frac{1}{2} \) establishing the comment period for the Funding Year 2012 Eligible Services List (ESL).

Comments on the draft ESL, which is attached to the Public Notice, aredue to the FCC on or before July 15, 2011. Reply comments are due to the FCC onor before July 25, 2011. For information on filing comments with the FCC, please refer to the Public Notice.

The Public Notice includes a summary of the changes being contemplated. The FCC has also included a redlined version of the ESL which highlights each of the specific proposed changes. The edits to the ESL provide clarifications or additional information, and are not intended to change the level of eligibility for services from the previous funding year.

# 4/14/2011 - USAC Provides Demand Estimate for Funding Year 2011 to FCC

On April 12, 2011, the Schools and Libraries Division of the Universal Service Administrative Company (USAC) reported to the Federal Communications Commission that \$4.31 billion in requested funding has been estimated for schools and libraries seeking discounts for Funding Year 2011. This estimate is based on the dollars requested in 44,139 applications received or postmarked by March 24, 2011, the close of the Form 471 application filling window. There are several factors that will reduce ultimately the funds requested from the estimated level. First, while efforts have been made to eliminate duplicate requests, inevitably we will discover more duplication as we process these applications. Second, USAC's efforts to assure that funds are committed only for eligible services, for use by eligible entities with the appropriate discount rate, and are otherwise consistent with program rules, will further reduce the demand.
