### Description


Contributors have the option to view the first page, also known as the summary page, of their invoice online. Invoice summaries for the past 24 months are available online.

At this time, only the summary page is available online. This page displays the following:

- Filer ID
- Invoicing month
- Total amount due
- Date due
- Support mechanism charges and credits for the month
- Late filing fees and/or late payment fees (if necessary)
- Payments received

- Navigate to a specific Filer ID by clicking on the Filer ID number in the list


