E-rate Productivity Center

- New online application system! (FY 2016 and beyond)
- Still in development
- FCC Forms 470, 471, 486, applicant 498

E-File

- Service provider account management
- FCC Form 498
- FCC Form 473 SPAC
- FCC Form 474

Legacy “Apply Online” system

- Legacy system; being phased out
- Some forms still in here while we work to move them to EPC (e.g., FCC Form 486 for FY 2015 and prior years)
- FCC Form 472 BEAR

FRN Status Tool

- First phase - standard report only - similar to the DRT
 - Provides funding request data for FY2016 and forward
 - Enter at least one required search criteria
 - Select at least one FRN service type
 - Select at least one applicant type
 - Enter optional criteria if you want to limit your search
 - Data results in Excel or XML feed
 - Standard report returns 19 fields of data

FRN Status Tool

- Second phase (under development - available in near future)
 - Select fields from a menu similar to “Select Data Points” in current DRT
 - Provides a detailed report with several new data fields
- For Funding Years 1998 to 2015 use the existing Data Retrieval Tool (DRT)

Note: The first version of the FRN Status Tool provides the ability to download the standard report for funding request data similar to the DRT. USAC will be adding the ability to download a "detailed" report in a second release of this tool which will include similar data to the DRT plus several new data fields.
