The funds are available to all entities within the United States and territories, all which could be included under this engagement. The only exception is the Marianna Islands which will not be part of this engagement.
36	Does USAC anticipate keeping the Key Personnel more or less 100% utilized throughout the entirety of the Contract Term?	The contractor will determine whether key personnel are 100% utilized through the entirety of the contract term.

USAC does not have any statistics on the types of network technologies used by the carriers. Note that the networks to be evaluated are mainly for wireline technologies.

No, the contractor cannot engage the carrier for assistance with testing. If carrier assistance is needed, the contractor will first confer with USAC.

The cost of tools are not reimbursable by USAC. The resource rates should include all direct and indirect costs. However, the travel expense associated with site visits can be submitted as

43	What is the expected volume of audits each firm should expect to receive?	Each firm will have the opportunity to bid on future Task Orders. The number of studies in each Task Order is TBD.
44	Does the USAC have guidance as to the % of expected travel for the program?	No, USAC does not have guidance to offer regarding the percentage of expected travel.
