Will the government consider a multi-award vehicle or allow the selected contractor to withdraw from the award if the selected contractor would not be able to able to perform the work under GAGAS professional standards?" Offerors shall propose a separate line item for Travel expenses.

If so, would USAC please provide the location of the carrier and specify what information offerors should include in their proposals regarding travel costs?	The location of the carrier will be provided at contract award. See USAC travel policy for allowable travel expenses.	
9	Section B.9.A.1, General Services (page 6): Section B.9.A.1 references a prior audit of the carrier. Would USAC please confirm whether those audit workpapers will be available for review during the forensic investigation?	Yes, the workpapers will be available for review.

Would USAC please either provide an estimated level of effort for this engagement or provide relevant information regarding the carrier (e.g., number of monthly subscribers) to enable offerors to accurately estimate the level of effort?	Staffing plan is required and the detail necessary to estimate resources will be provided after USAC receives a signed Non-Disclosure Agreement.	
13	Section B.9.A.6(a) (pages 7 and 8): Would USAC please identify the type(s) of statistical projection(s) it will require the contractor to use when projecting potential improper payments?	The Contractor is required to use a statistical valid sample and make projections based on exceptions noted.	
14	Section B.9.A.6(b) (page 8): This section states that the contractor shall specify the standards employed to perform the forensic investigation. Based on the description of the work, it appears that the contractor would be required to perform the work under American Institute of Certified Public Accountants (AICPA) Statement on Standards for Forensic Services No. 1. Would USAC please either confirm that the contractor shall use the AICPA Statement on Standards for Forensic Services No. 1 or provide additional information regarding the standards under which it expects the contractor to perform the services?	Confirmed, it is required to perform the forensic audit work under American Institute of Certified Public Accountants (AICPA).	
15	Section B.10, Travel (page 9): Section B.10 states that USAC is not obligated to make payments in excess of the ceiling price set forth in Attachment 2. However, Attachment 2 only includes labor rates for the seven labor categories; it does not require the offeror to provide an estimated number of hours by labor category or calculate a ceiling price. Would USAC please clarify how it will determine the ceiling price? Would USAC please clarify whether offerors should provide option year pricing, and if so, for how many option years?	The RFP is for one-year contract.	
22	Is this a recompete of an existing contract?	This is not a recompete of an existing contract. It is a new requirement.	
23	Does USAC anticipate a manual review portion for the project?	Please explain.	
24	As responding to an RFP can take significant time and effort, as does USAC choosing a firm for this work, would it be possible to obtain the name of the carrier upfront to avoid any independence or conflicts of interest that may exist?
