- a1. Approval of Rural Health Care Committee Meeting Minutes of October 26, 2009. On a motion duly made and seconded, the Committee approved the minutes, as written, of the Committee meeting of October 26, 2009.
- **a2.** Approval of 2nd Quarter 2010 and 2010 Annual Rural Health Care Support Mechanism Programmatic Budgets. Mr. Belden presented this item to the Committee, noting that there was no change from the budget presented to the Committee in October.

On a motion duly made and seconded and after discussion, the Committee adopted the following resolutions:

RESOLVED, that the USAC Rural Health Care Committee approves a 2nd Quarter 2010 Rural Health Care Support Mechanism budget of \$2.4 million; and

RESOLVED FURTHER, that the USAC Rural Health Care Committee directs USAC staff to submit a collection requirement of \$2.4 million for Rural Health Care Support Mechanism administrative expenses in the required January 29, 2010 filing to the FCC on behalf of the Committee; and

RESOLVED FURTHER, that the USAC Rural Health Care Committee approves an annual 2010 Rural Health Care Support Mechanism budget of \$11.8 million.

a3. Approval of 2nd Quarter 2010 Rural Health Care Support Mechanism Demand Projection for the January 29, 2010 FCC Filing. Dr. England presented this item to the Committee.

On a motion duly made and seconded, and after discussion, the Committee adopted the following resolution:

RESOLVED, that the USAC Rural Health Care Committee, having reviewed at its meeting on January 25, 2010, a summary of the 2nd Quarter 2010 Rural Health Care Support Mechanism demand estimate, including administrative costs, hereby directs USAC staff to proceed with the required January 29, 2010 filing to the FCC. USAC staff may make adjustments if the variance is equal to or less than \$1.0 million, or may seek approval from the Rural Health Care Committee Chair to make adjustments if the variance is greater than \$1.0 million but not more than \$2.0 million.

- **a4. Recommendation for Annual Election of Committee Chair and Vice Chair.** Dr. Sanders noted that the FCC Chairman has not yet selected nominees for the six open USAC Board of Directors (Board) seats, and, based on management's recommendation, the Committee would carry on with current Chair and Vice Chair, therefore, no action was taken on this matter.
- **a5. Miscellaneous.** Solicit ideas for the April 2010 Committee Agenda. Dr. Sanders reminded Committee members that they may offer suggestions for agenda items at each quarterly meeting. Ideas may be submitted to Dr. Sanders, Dr. Kragel, Mr. Barash or Dr. England between quarterly meetings.

INFORMATION ITEMS:

- **i1. Rural Health Care Support Mechanism Update.** Dr. England presented this item to the Committee, noting that:
 - USAC has received a total of 3,520 FCC Form 465 applications and 2,354 FCC Form 466/466-A packets for Funding Year 2009.
 - RHC program staff continues to work closely with USAC Information Technology (IT) staff to develop and implement system enhancements to increase automation and operating efficiency of application processing and to plan for future systems modernization. A statement of work to determine the current and future system needs has been completed.
 - RHC Program beneficiary appeals, which include both the primary and Pilot Program, remained low this quarter at 10. Of the 10 appeals received, two were resolved and eight are currently under review.

- The RHC Program continues its outreach efforts to health care providers (HCPs) and service providers, focusing on improving the applications submitted by HCPs and ensuring a faster turnaround time from submission to funding.
- A significant number of administrative changes to improve program efficiency were implemented in 4th Quarter 2009. These changes improved data accuracy and application processing efficiency and allowed USAC to email support schedules, which previously could only be sent via U.S. mail.
- **i2**. **Rural Health Care Pilot Program Update.** Dr. England presented this item to the Committee, noting that during 4th Quarter 2009:
 - USAC posted 5 RFPs for competitive bidding.
 - USAC committed \$2.18 million to 6 projects.
 - USAC disbursed \$5.06 million to 14 projects.
 - USAC received one Pilot Program appeal. To date, USAC has received three appeals for the Pilot Program. One appeal has been decided and two appeals remain pending. The two pending appeals involve an issue for which USAC is seeking policy guidance from the FCC
- i3. Schools and Libraries and Rural Health Care Program Support Services Solicitation Update. In accordance with the approved criteria and procedures for conducting USAC Board and committee business in *Executive Session*, Mr. Capozzi recommended that discussion of this item be conducted in *Executive Session* because this matter relates to USAC's *procurement strategy and contract administration*.

On a motion duly made and seconded, the Committee adopted the following resolution:

RESOLVED, that the USAC Rural Health Care Committee determines that discussion of the Schools and Libraries and Rural Health Care Program support services solicitation shall be conducted in *Executive Session*.

 - For Funding Year 2009, USAC has posted 3,791 FCC Form 465 applications and has received 3,834 FCC Form 466/466-A packets.
 - For Funding Year 2010, USAC has posted 439 FCC Form 465 applications.
 - RHC program staff continues to work closely with USAC Information Technology (IT) staff to develop and implement system enhancements to increase application processing automation and operating efficiency and to plan for future systems modernization. An RFP (Request for Proposals) to determine current and future system

needs is currently being developed to address potential requirements proposed in the FCC Broadband Report.

- There were ten RHC Program beneficiary appeals this quarter, primarily resulting from applicant contract violations and consequential loss of funding. Of the ten appeals received, one was resolved and 14 are currently under review.
- The RHC program staff continues its outreach efforts, including developing a training program for new health care providers (HCPs) that focuses on improving the applications submitted, thus ensuring a faster turnaround time in processing applications, reducing funding denials and creating fewer appeals.
- RHC implemented additional administrative changes to improve program efficiency in 1st Quarter 2010. Changes included creating and executing a quality assurance program, continuing with fund year closeout efforts and creating and finalizing internal policies and procedures.
- USAC program staff provided a summary of the impact of the National Broadband Plan on the RHC Program. A discussion of the plan will be held in the quarterly Board of Directors meeting on April 27, 2010.
- The RHC Program Outreach Plan for 2010, developed by the RHC and the External Relations team, includes the goals and activities comprising USAC's efforts to educate and communicate with program audiences about successful participation in the Rural Health Care Program.

Mr. Iversen presented the USAC Rural Health Care Outreach and Education Plan to the Committee.

- **i2**. **Rural Health Care Pilot Program Update.** Dr. England presented this item to the Committee, noting that:
 - O During 1st Quarter 2010 (1Q2010), USAC posted 12 Form 465 packages representing six projects; issued 25 funding commitments totaling \$29.80 million; and disbursed \$3.21 million in Pilot program support.
 - Since the Pilot Program's inception through March 31, 2010, USAC has posted
 73 Form 465 packages for 46 projects; issued 78 funding commitments totaling
 \$58.66 million to 26 projects; disbursed \$15.05 million in Pilot Program funds to

- 20 projects; and has verified the eligibility of almost 5,000 health care providers participating in Pilot Program networks.
- o Funding commitments and disbursements are expected to increase next quarter.

- **i1. Rural Health Care Support Mechanism Update.** Dr. England presented this item to the Committee, noting that:
 - USAC received 3,942 FCC Form 465 applications and 7,934 FCC Form 466/466-A packets for Funding Year 2009. In addition, 3,171 FCC Form 465 applications and 227 FCC Form 466/466-A packets for Funding Year 2010 have been received.
 - RHC program staff continues to work closely with USAC information technology (IT) staff
 to develop and implement system enhancements to increase application processing
 automation and operating efficiency and to plan for future systems modernization.
 - There were seven RHC Program beneficiary appeals this quarter, primarily resulting from applicant contract violations and consequential loss of funding. Of the seven appeals received, none were resolved but seven prior appeals were resolved, leaving 16 currently under review.
 - RHC program staff continues outreach efforts, including developing and conducting two training sessions for health care providers (HCPs) and service providers. Staff also attended, exhibited and presented at the 15th Annual American Telemedicine Association conference, the 4th Biannual Alaska Rural Health Conference and the National Rural Health Association annual conference.

- RHC staff continued to respond to requests for information from the Government Accountability Office (GAO), which is conducting a review and preparing a report on the Rural Health Care Program.
- **i2**. **Rural Health Care Pilot Program Update.** Dr. England presented this item to the Committee, noting that:
 - During 2nd Quarter 2010, USAC posted seven Form 465 packages representing four projects; issued nine funding commitments totaling \$5.54 million; and disbursed \$6.61 million in Pilot Program support. Since the Pilot Program's inception through June 30, 2010, USAC has posted 80 Form 465 packages for 46 projects, issued 89 funding commitments totaling \$64.20 million to 29 projects; disbursed \$21.77 million in Pilot Program funds to 20 projects; and verified the eligibility of almost 5,726 health care providers participating in Pilot Program networks. Funding commitments and disbursements are expected to increase next quarter.
 - USAC continues to hold monthly conference calls for coaches and project coordinators.
 USAC completed one-on-one meetings with all projects during 3rd Quarter 2009 and in
 1st Quarter 2010, started one-on-one meetings focused on projects that appear to be
 lagging and might still have difficulty completing their design, vendor selection and
 funding requests by the revised FCC deadline of June 30, 2011. These meetings provide
 tailored support through the application process. In addition, at the FCC's request,
 USAC is assessing the reasons for each project's delay and the potential to achieve
 project goals.
 - USAC staff meets weekly with FCC staff to discuss and clarify policy and program issues
 that arise as projects develop and to ensure that USAC is correctly implementing
 program requirements. USAC staff continues to assist Pilot Program project
 coordinators by discussing project-specific issues and by reviewing draft documents
 such as letters of agency, requests for proposals, or Form 465 attachments.

RESOLVED, that the USAC Rural Health Care Committee determines that discussion of the Rural Health Care Support Mechanism budgets shall be conducted in *Executive Session*.

a3. Approval of 1st Quarter 2011 Rural Health Care Support Mechanism Demand Projection for the November 2, 2010 FCC Filing. Dr. England presented this item to the Committee.

On a motion duly made and seconded and after discussion, the Committee adopted the following resolution:

RESOLVED, that the USAC Rural Health Care Committee, having reviewed at its meeting on October 25, 2010, a summary of the 1st Quarter 2011 Rural Health Care Support Mechanism demand estimate, including administrative costs, hereby directs USAC staff to proceed with the required November 2, 2010 filing to the FCC. USAC staff may make adjustments if the variance is equal to or less than \$1.0 million, or may seek approval from the Rural Health Care Committee Chair to make adjustments if the variance is greater than \$1.0 million but not more than \$2.0 million.

Miscellaneous. Solicit ideas for the October 2010 Committee Agenda. Dr. Sanders reminded Committee members that they may offer suggestions for agenda items at each quarterly meeting. Ideas may be submitted to Dr. Sanders, Dr. Kragel, Mr. Barash or Dr. England between quarterly meetings.

INFORMATION ITEMS:

- **i1. Rural Health Care Support Mechanism Update.** Dr. England presented this item to the Committee, noting that:
 - USAC received 3,942 FCC Form 465 applications and 7,989 FCC Form 466/466-A packets for Funding Year 2009. In addition, USAC has received 3,589 FCC Form 465 applications and 1,623 FCC Form 466/466-A packets for Funding Year 2010.
 - RHC program staff continues to work closely with USAC Information Technology (IT) staff to develop and implement system enhancements to increase application processing automation and operating efficiency and to plan for future systems modernization.
 - There were nine RHC Program beneficiary appeals received this quarter, primarily resulting from applicant contract violations and consequential loss of funding. Of the nine appeals received, one was resolved and 11 prior appeals were resolved, leaving 15 currently under review.
 - RHC program staff continues outreach efforts, including developing and conducting two webinars for service providers in 3Q2010. A new program manager was recently hired to focus on outreach efforts; she has worked closely with the external relations team on the website, and developing conference and training materials.

- The Government Accountability Office (GAO) has completed its fieldwork and is
 preparing to issue a draft report on Rural Health Care Program objectives and
 performance. USAC has worked with the GAO throughout their review
 responding to information requests and anticipates submitting a response to the
 draft report.
- USAC continued the Payment Quality Assurance (PQA) Program that was initiated in August 2010. PQA will enable USAC to provide information about improper payments to the FCC as required by the Improper Payments Information Act of 2002 (31 U.S.C. § 3321) (IPIA).
- An FCC Notice of Proposed Rulemaking (NPRM) to create new broadband support mechanisms for the Rural Health Care Program was published in the Federal Register on August 9, 2010. Sixty entities filed comments and 39 filed reply comments during the comment period that closed September 23, 2010.
- **i2**. **Rural Health Care Pilot Program Update.** Dr. England presented this item to the Committee, noting that during 3rd Quarter 2010:
 - USAC posted 8 Form 465 packages representing 8 projects, issued 49 funding commitments totaling \$25.8 million, and disbursed \$5.48 million.
 - RHCP staff verified the eligibility of almost 132 Health Care Providers participating in Pilot Program networks.
 - There were no appeals from Pilot Program beneficiaries.
- i3. Schools and Libraries and Rural Health Care Program Support Services Solicitation Update.
