



Lifeline Introduces Quarterly Webinars for Tribal Partners in 2021

Dear Tribal Leader,

The Lifeline program, which is administered by the Universal Service Administrative Company (USAC) under the policy guidance of the Federal Communications Commission, offers a monthly discount of up to \$9.25 toward phone or Internet services for eligible consumers and up to \$34.25 for those living on [federally recognized Tribal lands](#). Additionally, certain residents of Tribal lands can receive reimbursement for the full cost of starting service with certain phone or Internet companies at their primary residence, up to \$100, through Lifeline's Tribal Link Up benefit.

This year, USAC will host free quarterly Lifeline webinars for Tribal stakeholders (e.g., Tribal governments and government agencies and nonprofits serving Tribal communities) to enhance collaboration with Tribal communities. During these interactive webinar sessions, Lifeline's subject-matter experts will provide attendees with important updates to ensure Tribal partners remain informed and have the tools and information they need to more effectively help eligible Tribal consumers apply for Lifeline service. Attendees will also have an opportunity to engage in a live Q&A session during each webinar.
