

### E-Rate

#### **Request a Waiver**

The FY2024 application filing window closed on Wednesday, March 27. Applicants who have not yet certified and submitted their FCC Form 471 may request a waiver of the FCC Form 471 application filing window deadline with the FCC by providing details of the circumstances that led to the late filing. Please be sure to certify and submit the FCC Form 471 before requesting a waiver. For more information, refer to the Submitting Window Waiver Requests section of the FCC Form 471 Filing page.

#### **Document Retention**

All program participants are required to retain receipt and delivery records relating to pre-bidding, bidding, contracts, application process, invoices, provision of services, and any other documentation demonstrating compliance with program rules for a period of at least 10 years after the last day of the applicable funding year or the service delivery deadline for the funding request.

## <u>ACP</u>

#### Affordable Connectivity Program (ACP)

On January 11, 2024, the FCC released an Order announcing the wind-down requirements of the ACP, due to a lack of additional funding from Congress. The last fully funded month of the ACP is April 2024. The ACP can only provide a partial reimbursement for May 2024, and ACP providers have the option to claim and pass on that partial reimbursement amount to enrolled households. As of January 25, the first round of provider notices regarding the ACP wind-down have been sent to ACP households. The second round of provider notices regarding ACP wind-down have been sent to ACP households as of March 19. The third round of provider notices will be included as part of the last bill or billing cycle in which the full ACP discount is applied. The providers are required to include in their

notices a reminder to ACP households of their right to change their service and/or to opt out of continuing their service at the end of the ACP. For additional information and updates relating to ACP wind-down, please visit AffordableConnectivity.gov or fcc.gov/acp.

## Rural Health Care (RHC)

#### FCC Releases Order DA 24-214 Extending the Deadline for FY2024 Filing Window to May 1, 2024

On March 7, 2024, the FCC released FCC Order <u>DA 24-214</u> extending the deadline for the FY2024 application filing window to May 1, 2024. This means all RHC funding requests (FCC Forms 462 or 466) must be submitted no later than 11:59 p.m. ET on May 1, 2024. We highly encourage you to submit your funding requests as early as possible in the filing window.

#### RHC Program Inflation-Based Cap Announced for FY2024

The RHC program funding cap for FY2024 is \$706,926,603. The internal cap for upfront payments and multi-year commitments under the Healthcare Connect Fund (HCF) Program is \$178,496,951. The internal cap for upfront payments and multi-year commitments will apply only if RHC program demand exceeds available funding. These new caps represent a 3.6 percent inflation-adjusted increase to the \$682,361,586 RHC program funding cap and the \$172,294,354 internal cap on multi-year commitments and upfront payments from FY2023. #### **Latest Results of CAF Compliance Monitoring Published**

As part of the Federal Communications Commission (FCC) <u>Rural Broadband Accountability Plan</u>, USAC has <u>published</u> the latest in a series of reports showing the results of the Connect America Fund (CAF) compliance process, an extensive oversight program that monitors carrier compliance with broadband deployment obligations to confirm that carriers receiving CAF support are using it to expand high-speed internet access and close the digital divide in rural America.
