11/8/2019 – Legacy System Outage Due to System Maintenance: November 11 & 12

The Schools and Libraries (E-rate) Program legacy systems will be unavailable on November 11, 2019 from 6:00 p.m. through 10:00 p.m. ET for system maintenance. On November 12, 2019, E-rate legacy systems will be unavailable from 6:00 p.m. through 10:00 p.m. ET for additional system maintenance.

During this time, users will be unable to file invoices and use some of the search tools. The BEAR training site will also be unavailable. We apologize for any inconvenience.

11/8/2019 – Coming November 11: Updated USAC Website

On Monday, November 11, 2019, USAC will launch an updated version of the USAC website. The updated site features design and functionality changes to help users find the information they need, when they need it. The site's new program homepages put key dates and resources front and center. Information will be updated throughout the year to reflect each program's lifecycle.

While most of the site's content hasn't changed, expanded menus make it easy to navigate to the information you need and improved search functionality makes it easier to find answers. For example, updated FAQs allow users to search by topic or specific keywords.

The site responds to mobile devices and all operating systems and meets 508 accessibility standards.

With the migration to the updated website, not all USAC URLs will be maintained. This means that any hyperlinks or bookmarks to USAC web content that are not maintained, including PDFs and CSV templates, will redirect users to USAC's updated landing page, USAC.org, where they can use the improved search functionality to navigate to the content they seek.

USAC's updated website will go live on Monday, November 11. For more information on USAC's new website, go to USAC.org on November 11 for a brief video highlighting some of the site's new features. Review and update your [E-rate Productivity Center \(EPC\)](#) profiles now. Each year, USAC updates applicant profiles in EPC using the reviewed and approved profile information from their current year FCC Forms 471. We do this so that applicants can start the application process for the upcoming funding year with information in their profiles that is accurate as of the date of their Funding Commitment Decision Letter (FCDL).

USAC has now completed this process for applicants that had updates in advance of the Funding Year (FY) 2020 application cycle. All applicants can now review their profiles and make any additional updates for changes that occurred after USAC's review of their FY2019 FCC Forms 471.

As in the past, the EPC administrative window will close – and the applicant profiles will be locked – shortly before the FY2020 application filing window opens. We will provide more information and reminders about profile updates in upcoming editions of the weekly [SL News Brief](#) to help participants get ready for the upcoming filing window.

The FCC has released a Notice of Proposed Rulemaking (NPRM) ([FCC 19-58](#) , released July 9, 2019) that proposes to make the Category Two budget approach permanent, and also seeks comment on potential modifications that could simplify the budgets, decrease the administrative burden of applying for Category Two services, and thereby speed the deployment of Wi-Fi in schools and libraries across the country.

Comments on the NPRM are due 30 days after the publication of the NPRM in the Federal Register. Reply comments are due 45 days after publication of the NPRM in the Federal Register. To submit comments, follow the instructions in the *Filing Comments and Reply Comments* paragraph in the NPRM.

On January 3, 2019, the Federal Communications Commission (FCC) released an order ([DA 19-15](#)) that waives specific E-rate Program deadlines that occurred on or after October 8, 2017 for schools and libraries located in the areas affected by the Northern California wildfires that occurred in October 2017. The fires caused power outages and damage to communications services, affecting the participation of schools and libraries in the E-rate Program.

Program participants in the affected area  have until **April 3, 2019** to submit the following filings to USAC:

[Requests for review or waiver of decisions by USAC](#), directed to USAC or the FCC.

[FCC Form 486](#) (Receipt of Service Confirmation and Children’s Internet Protection Act Certification (CIPA) Form).

[FCC Form 472](#) (Billed Entity Applicant Reimbursement (BEAR) Form) and [FCC Form 474](#) (Service Provider Invoice Form). **By waiving the invoicing deadline, the FCC also extended the deadline to submit a Service Provider Identification Number (SPIN) change request.*

Next Steps for Affected Entities

To take advantage of the deadline extensions referenced in the Order you must notify USAC that an extension is needed.

The first step is to open a customer service case in the E-rate Productivity Center (EPC).

At the beginning of the case nickname, enter the code "DA 19-15" to assist us in locating and responding to your questions or request.

The following information should be included in your customer service case: Funding Request Number(s) (FRNs), Billed Entity Number (BEN), Billed Entity name, the type of request you are seeking (i.e., invoice deadline extension) and a description of the request.

USAC will process these customer service cases to ensure the relevant filing deadline is extended.
