Pilot Program: Process and Timeline

Pilot Program Participants: Timeline



1

- Participants must complete a minimum 28-Day **Competitive Bidding** process using a Pilot or other establishing FCC Form 470 to seek bids for **eligible** cybersecurity equipment and services.
- The Pilot FCC Form 470 is available in the Cybersecurity Pilot Program portal now and must be completed by August 18, 2025 to be considered timely filed.



2

- Participants submit Pilot Program **Funding Request(s)** using the Pilot FCC Form 471.
- The Pilot Program FCC Form 471 application filing window runs from March 18 – September 15, 2025.



3

- Participants must also complete the **Pilot FCC Form 484 Part 2**.
- Participants must complete Pilot FCC Form 484 Part 2 by September 15, 2025 (the close of the Pilot FCC Form 471 application filing window) **and** submit the Pilot FCC Form 471 to be able to receive funding a commitment decision letter (FCDL).

Pilot Program: Pilot FCC Form 471 Overview

Pilot Program: Pilot FCC Form 471 Overview

- After Pilot participants complete the competitive bidding process and select a service provider, they may request Pilot Program funding using the Pilot FCC Form 471.
- As in the E-Rate program, Pilot participants will be asked to provide the following information on their Pilot FCC Form(s) 471:
 - Recipients of services and equipment;
 - Selected service provider(s);
 - Detailed descriptions of the services and equipment requested, including their costs and dates the services were provided or equipment was delivered; and
 - Certifications confirming compliance with Pilot Program and Children’s Internet Protection Act (CIPA) rules.
- Pilot participants will also be required to specify the invoicing method (i.e., Service Provider Invoicing (SPI) or Billed Entity Applicant Reimbursement (BEAR) method) they plan to use for each funding request on the Pilot FCC Form(s) 471 and must submit Pilot FCC Form(s) 471 to cover the full Pilot Program period (i.e., the full three-year term).
- The services and equipment for which funding is sought on the Pilot FCC Form 471 must match the services and equipment for which bids were sought in the establishing FCC Form 470.

Pilot FCC Form 471 FRNs and FRN Line Items

- **Each FRN must contain all of the following information:**
 - Billed Entity Number (BEN)
 - Contract information (award and end dates)
 - Category of cybersecurity equipment and/or service (advanced/next generation firewalls; endpoint protection; identity protection and authentication; or monitoring, detection, and response)
 - Establishing FCC Form 470 number
 - Service Provider (SPIN)
 - Purchasing method (contract, month-to-month, or Master Services Agreement or State Master Contract)
 - Contract ID (if you have one)
 - Service start and end dates
- **Each FRN line item must contain all of the following information:**
 - Equipment or service
 - Pricing and quantities
 - Recipients of service (Consortia only)

Pilot FCC Form 471 Review Process

- To ensure compliance with the FCC's rules, the Pilot FCC Form 471 will be subject to Program Integrity Assurance (PIA) reviews similar to the reviews USAC conducts on the FCC Form 471 submitted in the E-Rate program.
- Pilot participants can expect USAC to reach out to the contact(s) listed on the FCC Form 471 to inquire about information provided on the form and/or request supporting documentation. To expedite the review of these forms, Pilot participants are encouraged to timely respond to such requests.
- All applications undergo an initial review and a final review to ensure the completeness and accuracy of the information provided on the form.
- Questions from PIA reviewers may relate to one or more of the following topics:
 - Eligibility of the services/equipment requested;
 - Cost Effectiveness of the services/equipment requested;
 - Ensuring that the requested funding does not exceed the participant's approved budget;
 - Contracts; and
 - The competitive bidding process.

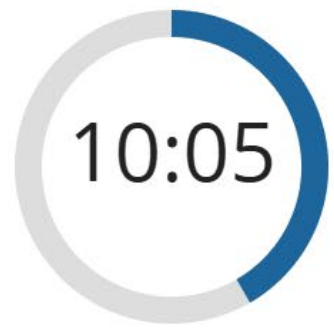
