Tribal Advocate Training Webinar for the Lifeline Program

Please feel free to share this webinar invitation with colleagues and other tribal community advocates.

The [Lifeline Program](#) is one of the four federal benefit programs administered by the Universal Service Administrative Company. Lifeline helps households obtain affordable connectivity services by providing a discount to low-income consumers.

Lifeline subscribers may receive up to \$9.25 off their monthly phone or internet bill and

Lifeline subscribers that live on federally recognized tribal lands may receive up to \$34.25 off their monthly bill. Consumers qualify for Lifeline through participation in [government programs](#) (such as SNAP or Tribal TANF) or if their [income](#) is at or below 135% of the Federal Poverty Guidelines.
