Construction

Costs incurred by either a service provider or health care provider for the construction of new network infrastructure or upgrades to existing infrastructure.

Equipment

Network equipment necessary to make a broadband service functional.

- Fiber Network Transport Equipment

Installation

Reasonable and customary installation charges for eligible equipment and services (up to \$5,000 in pre-discount costs per location).

Network Management Services*

Services that support network operations on a one-time or continuing basis. Individual applicants are not eligible to receive funding for network-based services as they are not considered to be a network. Managed Service Providers (MSPs) are third party organizations that provide essential services on a limited or continuous basis.
